The Bidders must submit their bid electronically through e-procurement section of PPMOs website <http://www.bolpatra.gov.np>, the Bidders may choose to download the necessary part of bidding documents, prepare their bid and submit their electronic bids as specified in the Instructions to Bidders. Bidder should download and submit bid electronically; the Bidder shall be required to deposit the non-refundable fee of NRs. 5,000.00. The method of payment will be in the form of cash deposit certificate in the **Revenue Title no 14229, Office code no 707367701, Account No.: ka 1-1-103** of Rastriya Banijya Bank, **Dhangadhi, Branch** and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.
3. Electronic Bid must be uploaded in PDF on or before 12.00 hours of 2075-11-26 (March 10, 2019). Bids received after the deadline shall not be accepted.
4. Bids will be opened in the presence of Bidders' representatives who choose to attend on 2075-11-26 (March 10, 2019) 2:00 PM at Ministry of Physical Infrastructure Development, Sudurpashchim Province, Dhangadhi, Kailali. Bids must be valid for a period of **90 days** counting from the day of bid opening.
5. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid. **For the bidders who have already submitted their bid before this Amendment Notice, It is requested to extend their bid validity period and bid security period according to this Amendment Notice.** Bank Guarantee issued by any finance company in any form will not be accepted.
